## Add-Ons: USDA Endorsement Fee

Adding the endorsement fee is optional. The fee is paid directly to the USDA at cost and will be included on your invoice.

- **USDA Endorsement Fee**
  - **\$101** for countries not requiring a lab test (i.e. rabies titer)
  - **\$160** for countries requiring a lab test
  - **\$206** for countries requiring 3-6 lab tests
